For districts covered by a Rotary International Office, you may choose to work through the office that services your area. If you write, please include a marked copy of your report indicating the discrepancy and a brief write-up of the problem. You should also give your name, telephone number, fax number, email address, and street address so that staff may assist you as expeditiously as possible.

Below is a glossary to help you better understand the EREY Eligibility Report:

Every Rotarian Every Year (EREY) Member: An individual who personally contributes some amount each year to the Annual Programs Fund. Contributions count toward Paul Harris Fellow, Multiple Paul Harris Fellow, Paul Harris Society and Major Donor recognition.

Rotary Foundation Sustaining Member (RFSM): An individual who personally contributes US\$100 or more each year to the Annual Programs Fund. Contributions are cumulative throughout the Rotary year and donors receive a Sustaining Member badge sticker from the club. Contributions count toward Paul Harris Fellow, Multiple Paul Harris Fellow, Paul Harris Society and Major Donor recognition.

Below is an explanation of the EREY Eligibility Report columns:

+: Indicates deceased individuals

Rotary ID: A Rotarian's Rotary International membership identification number. If the account holder is a non-Rotarian, this is his/her donor account number. An individual should have only one account number. That number will always contain a Rotarian's membership and contribution history. Duplicate accounts should be reported to The Rotary Foundation as outlined above.

Name: Listed are all constituents associated with a Rotary Club. There should be only one account per name. Duplicate accounts should be reported to The Rotary Foundation as outlined above. Please note that name prefixes and and titles do not appear on the report, eg.: Mr./Mrs./Ms.; Dr./Rev./Hon./.

Club Member: This column states whether the person is a current, active, Rotarian in the Rotary club under which his/her name appears. Y = Active Member.

EREY Date Achieved: A donor becomes an EREY Member when they personally contribute any amount to the Annual Programs Fund (APF-SHARE) in the designated Rotary year.

Sustaining Member Date Achieved: The date in which the individual's personal giving to the Annual Programs Fund reached or surpassed US\$100 during the designated Rotary year.

PHS Eligible Date Achieved: The date in which the individual's personal giving to the Annual Programs Fund or other approved programs reached or surpassed US\$1,000 during the designated Rotary year.

EREY Club and 100% Rotary Foundation Sustaining Member Club banner recognitions are awarded annually at the close and audit of the 30 June books. To qualify, for these club banner recognitions, the club must have a US\$100 per capita.

PHS recognition is a district-administered recognition.
