Southern New Jersey Council, Boy Scouts of America, and J.J. This is the first time this recognition is being bestowed on a company. A presentation dinner in their honor will be held at Adelphia Restaurant, Deptford, New Jersey, Thursday, June 5, 2008, starting with fellowship at 6:15 P.M. and dinner at 7:00 P.M.

Mr. John Pickering, Vice President and General Manager for The Valero Refining Company-New Jersey will accept the award on behalf of the company and employees. This fall, Valero Refining Company - New Jersey will mark its 10th anniversary as owner of the "Paulsboro Refinery". Part of Valero Energy Corporation, ranked #1 on the *Forbes* Best Big Places to Work in America, the Paulsboro Refinery has more than 550 employees. Located on 950 acres along the Delaware River in Greenwich Township, the refinery operates 24 hours-a-day year round, produces all types of petroleum products, has a total feedstock throughput capacity of 184,000 barrels-a-day, and ships its products across the northeastern U.S.

Since purchasing the refinery in 1998 and making its entrance into Gloucester County, Valero has invested more than \$1 billion in upgrading and expanding the Paulsboro Refinery. Its commitment to safe, environmentally sound, and reliable operations has earned the company designation as an OSHA Voluntary Protection Program Star Site, National Petrochemical Refiners' Association Achievement, Gold and Merit Awards, a New Jersey Business & Industry Environmental Excellence Award, two Chemistry Council of New Jersey Chairman's Awards, a Chamber of Commerce of Southern New Jersey Pinnacle Award and a Southern New Jersey Development Council Legacy Award.

Valero also strives to be an exemplar of corporate social responsibility. In 2007, refinery employees raised close to \$700,000 for the United Way of Gloucester County, representing 25 percent of the total campaign proceeds. This year, through the generosity of its corporate partners, contractors, suppliers and vendors, the company distributed \$357,000 in proceeds from the Valero Benefit for Children Golf Classic to 22 local children's charities. Valero employees serve as directors or advisors on numerous community business and non-profit boards, are strong supporters of the Boy Scouts Council of Southern New Jersey, and their employees, family members and contractors donate thousands of hours to volunteer activities in 60 different community projects each year.
